Meeting was called to order at 6:30pm.

Pledge of Allegiance was recited.

Comegys made a motion to approve the Minutes from the November 7, 2018 meeting. Ruffner second the motion. A vote of 3-0 was entered.

Francis Kinnamon of the SVFC asked for a credit for the quarterly Water Bill due to a leak that occurred. Kinnamon suggested that the cost of the bill be split 3 ways between MES, the town and the fire company. Comegys asked if MES was liable for the leak. Manning stated no. Kinnamon made note that regardless of the outcome of the request that the relationship between the town and the fire company would remain the same.

Ruffner made a motion to approve a \$10,033.63 credit to the sewer side be given to the Fire Company, Comegys second the motion. A vote of 3-0 was entered. Kinnamon asked that a new bill reflecting the credit be sent. Manning advised it would come thru email.

Manning introduced ordinance 2018-03 (distilleries). Manning stated it will be voted on at the next meeting. Ruffner made a motion to adopt ordinance 2018-01 trailer ordinance. Comegys second the motion. A vote of 3-0 was entered.

Ford read ordinance 2018-02 revision to the current quarterly water billing going to monthly water billing. Ruffner made a motion to adopt ordinance 2018-02, Comegys second the motion and a vote of 3-0 was entered.

Faye Williams suggested a fund for Christmas lights, states plenty of business to help with the funding.
